The If Only Program seeks to prevent incarcerated people from re-entering the criminal justice system after release and advocates for change within prisons to facilitate successful transitions back into the community.

- Doubled the number of volunteer mentors from 10 to 20 within one year by sharing the mission of the If Only Program on social media and through speaking at community events.
- Expanded and enhanced the mentor training program from 12 hours to 25 hours with ongoing training and created a Mentor the Mentor initiative where experienced mentors support new mentors.
- Meet weekly with prison staff to coordinate activities and events for mentees and advocate for changes in visitation and communication to offer additional avenues for building relationships between incarcerated mentees and community mentors prior to release.
- Advocate for legislative changes to allow for increased educational opportunities for incarcerated individuals.
